Must provide proof of incorporation and must have been incorporated for at least one year to qualify. A maximum of 4 assignees is permitted per membership; multiple memberships may be purchased. All assignees must prove that they work for the same corporation. The Activation Fee is required at time of signing. Membership is contracted at the monthly rate above for one (1) year from date of purchase. Dues may be paid in full in advance or in monthly installments. For membership WITHOUT the cart plan included, the per person, per round cart fee is \$16 at all courses, except at Southern Pines where it is \$20. Corporate members who do not fulfill their one-year contract and wish to re-join within a year of their resignation will be required to pay dues for the months they are absent, plus the \$2,000 Activation Fee.
